## **MINUTES**

- 1. Call to Order took place at 6:00 pm
- 2. The Pledge of Allegiance took place.
- 3. Attending were Belinda Kurtz, Tracy Pepper, Desire Sprosty (C), (GT)- Mark Smith, JC Watkins, Paul Romero, Jerry Barber, Jeremiah Buford (Late-8B 6:08p)
- 4. The Additions/Changes to the agenda: 8J Audit update, 10D Colorado Canal, 14. C. Black Hills
- 5. A. The Changes to the agenda were approved 6-0, Pepper (M), Kurtz (S)
  - B. The agenda was approved with changes 6-0, Kurtz (M), Pepper (S)
- 6. The September 27, 2021 minutes were approved 6-0, Smith (M), Romero (S)
- 7. Public Comment: (those individuals interested in speaking, please sign in at the beginning of the meeting. Comments are restricted to five minutes per person. (NONE)
- 8. Old Business-
  - A. The Faw Wells installation project is entering the final stages with ground work expected by first week of November.
  - B. The town has completed the necessary legal work on 3 properties in the demolition program and EPA have been contacted to start the tear down process. Two others properties on the demolition program list have been torn down.
  - C. ADP Payroll was a success. The first payroll cost the town \$53.00
  - D. Skate Park-Bid Status was discussed and the town approved the sale to Chris Geringer for \$500, 6-0, Watkins (M), Buford (S)
  - E. The State Auditor Funds withholding report was shared with a balance of right at \$560,000.00.
  - F. The town was able to get out of the Springs Hosting contract that was entered into In 2018 and there was no record of and wasn't being used. The town was made aware when a bill was received. Springs Hosting caused no problems.
  - G. SCEDD Letter of Support was sent joining the partnership to bring housing into the 5-county region.
  - H. The Pivot Energy agreement was discussed.
  - I. The town has 678.68-acre feet of project water stored in Lake Pueblo. An Acre ft. of water is 326,000 gallons and can only be used for municipal town use.
  - \*J. Audit-Corbin Fromm reported that the draft 2018 Audit had been turned over and they are waiting on a response to the checklist sent to the town that they were working on.

  - \*D. Project Water/Colorado Canal Water Future Use Plan Development was discussed. the town will visit with Colorado Canal Company about lease of extra water, if any in 2022.
