

### TOWN COUNCIL MEETING

June 13, 2022

#### **MINUTES**

- 1. The meeting was called to order at 6:12 PM.
- 2. The pledge of allegiance took place.
- 3. Roll call was taken with council members Kurtz, Pepper, Romero, Watkins, Barber present. Also present: Phil Malouff (TA), Karen Gates (Town Administrator), Tom Henley-Black Hills Energy
- 4. Swear in Trustee Buford-Item Removed
- 5. Appoint Mayor Pro Tem-Item Removed
- 6. Additions/Changes to the Agenda: Remove Items 4 and 5. Add Items 11 S-Food Truck Friday,
- 11 T-Tree City USA Signs, and 11 U-4-H Fundraising
- 7. A. Approve Changes to the Agenda
  - B. The agenda was approved 6-0. Watkins (M), Romero (S)
- 8. The May 9, 2022, minutes were approved. 6-0. Pepper (M), Smith (S).

- D. Town Administrator Karen Gates updated the Council regarding a conversation with DOLA and the Conservation Trust Fund monies. DOLA inquired as to the status of the audits for the Town and offered any assistance in regards to becoming compliant with the audits so that funding could be released.
